

(F) DRIVERS OF BOARD-OWNED OR OPERATED, OR CONTRACTED VEHICLES OTHER THAN SCHOOL BUSES.

QUALIFICATIONS SHALL INCLUDE:

- (1) BEING 18 YEARS OF AGE WITH A MINIMUM OF TWO YEARS DRIVING EXPERIENCE.
- (2) AN ANNUAL DRIVER RECORD CHECK WITH NO MORE THAN EIGHT POINTS AND/OR NO SIX POINT CONVICTIONS WITHIN THE LAST TWENTY-FOUR MONTHS AS VERIFIED BY AN ABSTRACT DRIVER RECORD OBTAINED THROUGH THE BUREAU OF MOTOR VEHICLES.
- (3) HOLDING A VALID DRIVER'S LICENSE.
- (4) PROOF OF FINANCIAL RESPONSIBILITY OR INSURED BY THE SCHOOL BOARD.
- (5) A SATISFACTORY REPORT FROM THE STATE BUREAU OF CRIMINAL IDENTIFICATION AND INVESTIGATION EVERY 6 YEARS. SATISFACTORY SHALL BE DEFINED BY THE SAME STANDARDS APPLIED TO PUBLIC SCHOOL EMPLOYEES.
- (6) MUST BE PHYSICALLY QUALIFIED (AS DETERMINED BY RULE 3301-83-07 OF THE ADMINISTRATIVE CODE.
- (7) COMPLETE PRESERVICE TRAINING AS FOLLOWS:
 - (a) COMPLETE A FOUR HOUR MINIMUM OHIO PRESERVICE DRIVER CURRICULUM (OR OTHER COURSE ONLY AS APPROVED IN ADVANCE BY THE PUPIL TRANSPORTATION SECTION OF THE OHIO prev DEPARTMENT next OF prev EDUCATION next.)
 - (b) SUBMIT EVIDENCE OF TRAINING TO THE REGIONAL PRESERVICE INSTRUCTOR.
 - (c) HAVE A CERTIFICATE OF ACKNOWLEDGEMENT OF VAN DRIVER TRAINING AS ISSUED BY THE OHIO PRESERVICE PROGRAM.
 - (d) A CURRENT SCHOOL BUS DRIVER CERTIFICATE SHALL BE CONSIDERED AS FULFILLING THESE REQUIREMENTS.
- (8) COMPLETE 2 HOURS OF ANNUAL INSERVICE TRAINING AS APPROVED BY THE SCHOOL DISTRICT TRANSPORTATION DEPARTMENT:
- (9) THE CERTIFICATE OF ANY PERSON WHO HAS NOT COMPLETED THE REQUIRED ANNUAL INSERVICE SHALL BE REVOKED. THAT PERSON MUST THEN SUCCESSFULLY COMPLETE ALL OF THE CERTIFICATION REQUIREMENTS AS LISTED ABOVE.
